(U) INVESTIGATIVE SUMMARY:

(U) Investigation by this office and review by Headquarters, U.S. Army Criminal Investigation Command (USACIDC), determined there was sufficient credible information to believe the offenses of Assault and Cruelty and Maltreatment did not occur as alleged.

(U) Investigation determined ██████████ was captured on 4 Jan 04, and detained by members of Task Force (TF) 6-26 ██████████. ██████████ alleged he was detained in Tikrit, IZ, and was then taken to BIAP, where, over the course of one evening, he was forced to take off all of his clothes, made to walk into walls blindfolded, punched in the back, kicked in the stomach, drug around the room, and forced to assume uncomfortable positions, such as lying down with his hands on the floor and his legs on top of a meal-ready-to-eat (MRE) box. ██████████ further alleged during this time he had cold water poured on him and was forced to stand in front of a running air conditioner.

(U) All attempts to identify, locate and interview personnel associated with ██████████ arrest and interrogations prior to his arrival at the Baghdad Central Confinement Facility (BCCF), Abu Ghraib, IZ, have met with negative results. There was no medical documentation found in ██████████ detainee files and all attempts to locate his medical records have met with negative results.

(U) This investigation was coordinated with MAJ ██████████ Staff Judge Advocate, 10th Special Forces Group, Special Operations Command, Forward Operating Base (FOB) Central, Baghdad, IZ, who opined there was no probable cause to believe the offenses occurred as alleged; therefore, they are unfounded.

subsequent to his capture, he was taken to a detention facility, believed to be near BIAP. Mr. [redacted] alleged during interrogations he was placed in front of an air conditioner after he was stripped naked. While in front of the air conditioner, cold water was poured on him. Also, Mr. [redacted] related he was made to carry a heavy box, which was connected to a rope around his neck, while blindfolded and naked. Further, Mr. [redacted] related he was told to hold meals ready to eat (MRE) boxes above his head in front of an air conditioner while cold water was poured on him. Mr. [redacted] related he was kicked and punched if his arms were lowered.

This statement is being handwritten by Special Agent [REDACTED] and translated by Interpreter [REDACTED] for Mr. [REDACTED]. On 4 January 04, about 11:30-12:30 at night I was sleeping at the house of a Taxi driver who was going to take me to Syria the next day, when the house was raided and I was detained. A bag was put over my head and my hands were tied behind my back. I was put on what I think was a min-bus and was driven from Baghdad Hi-Al Shaab to Saddam International Airport. I was taken to a small wood room where I was searched and they took my glasses and watch. I was taken to a second room that was white with an air conditioner in the window, where they took my picture and asked my personal information. I was interrogated in the room. I stood there for about 5 minutes, before the bag was taken off my head. I saw the interpreter and taken into the interrogation room. These two men did not touch me. I spent 1/2 hour with these two asking me questions about money. I did not know what they were talking about and they accused me of lying to American Intelligence. The civilian left and the interpreter told me to take off my clothes. I asked why and the interpreter stated I will let you bag me to tell the truth. He told me to take my clothes off or he would have them taken off by force. I took off the sport suit I was wearing. The interpreter told me to take off my underwear and T-shirt also. I argued with him but he told me again he'd have my clothes taken off by force. So I took off all my clothes. Then he put the bag back over my head. I was taken to another room that had black walls, and an air conditioner. Water was poured on the bag, my neck and shoulders, the air conditioner was turned very cold and I was made to stand in front of it. The only light in the room was a flashlight. There was a stereo in the room. They made me listen to a bad movie in English language, then some American Music then sounds of children crying. A box was put over my head and something wet on my neck. I was told to walk from wall to wall. I could not see and walked into the walls, which would press the box into my chest. This caused me pain which lasted a couple weeks. The interpreter asked if I would now tell the truth. I told him I had said every thing I know. He asked me if I was tough enough to continue. I told him no. He put me in front of the air conditioner and poured more cold water on me, keeping me wet. Then he put an MRE in each of my hands and made me push them toward the ceiling. I held them up for a while then my arms began to drop. Someone punch me in my spine, below my shoulder blades with a fist. I passed out

 after about 5 minutes and fell to the floor. Someone grabbed me by the arm and drug me around the room. The interpreter took the bag off my head. Then I was made to lay on the floor, on my stomach, my arms out in front of me, with my palms to the ceiling. They put an MRE box across my forearms and had me place my chin on the top of the box. Now my stomach was not touching the floor. They put another MRE box across the back of my legs. This did not hurt at the time, but afterwards it was painful. Next I was made to put my hands on the floor and hold my body up. An MRE box was placed under my shins. As I began to go down I was kicked in the stomach. This caused me to vomit. The bag was taken off my head. The civilian put water in my hands and told me to wash my face and chest where there was vomit. A female entered the room, looked at me and left. She was there for less than 30 seconds and did not touch me. The interpreter was going to put the bag back on my head but the civilian told him to get a new bag. The civilian told the guards not to put a bag on my head any more, but to keep me wet and make me keep walking. The interpreter and civilian left and kept I would get water poured on me every 2-3 minutes. The interpreter brought in a photo and asked who it was. I told him it was my uncle who had died. I was kept wet and walking until 8:00 am, when I was taken to a room with the interpreter and the civilian. I asked for my clothes and was told I could have them after questioning. I was asked about my passport and where I got it. I gave a photo to a friend who got my passport for me. I was asked who gave me the passport and I agreed to show them. I was given my clothes, and I was taken by helicopter to show them the location. After I showed them the location I was taken to Abu Ghraib.

Q. Can you describe these people?

A. Yes. The interpreter was short 5'5" - 5'8", medium build, very white skin, green eyes, no hair, a medium voice. I heard him called [REDACTED] I think he was Lebanese from the way that he talked.

The civilian was 5'10" - 6'0" tall, a very large chest and arms, very white, blonde hair that was longer and combed to the side. He had a blonde mustache and small beard, a round face with green eyes. He wore gold metal glasses with round lenses. He wore a T-shirt and pants but I do not remember the colors. He had white sports shoes. He had a black baseball hat with an American flag on it. He had a gold ring on, like a marriage ring but I don't remember what finger or hand.

There was a black male about 6'0" or taller, skinny, very dark complexion, no glasses, very short hair, small ears and a very deep voice.

There was a second black male about 5'9" very strong and muscular, almost as dark as the other black male, short hair, a normal voice.

There was a white male about 5'9" well built with big muscles, light complexion, whose face was very large and round. He had short dark brown hair, no glasses and a normal voice. He wore a very large, round silver watch with hands, not digital.

There was a second white male about 5'9", soft and sk

with no muscles. He was very white. He may have been part asian as his eyes were asian type. He did not have glasses and I don't remember his eye color. He had longer black hair. He had a soft thin voice. There was a third white male about 5'2" and muscular. His skin was white and red. His face was round and large and he had no hair. His eyes were green and he had a normal voice.

There was a woman who was 5'5"-5'6", medium build, ~~white~~ white skin, dark color eyes, black/brown long hair that was pulled up and she had a soft voice.

Q. What money were you being questioned about?



FINDINGS OF DATE REVIEW:

1. No effort was made to identify and interview the interrogators and screening personnel who were working at the Temporary Screening Facility (TSF) during the time period of the alleged incident (4-5 Jan 05). The detainee provided very good descriptions of the interpreter [REDACTED] as well as other individuals who were involved or present during the abuse and it may be possible to identify suspects based on his descriptions.
2. The "lost records" explanation is unacceptable. Capture reports and interrogation reports do not just sit in a database on a local hard drive. They are submitted to higher echelons as well as other intelligence activities in an expeditious manner. The bottom line is this detainee's circumstances were rather unique, due to his relationship to another high value detainee (as detailed in the case file). Because of this relationship, the interrogators would have prepared and submitted a report to higher echelons. There is not indication that we had MI or the TSF search the available databases for any reports pertaining to this detainee.
3. During his interview with CID, the detainee stated he agreed to show the interrogators where the person lived who provided his fake passport. The detainee stated he was taken by helicopter to show the interrogators the location and then he was taken to Abu Ghraib. Again, more information that can be used to distinguish this detainee from other detainees and assist in identifying the individuals who interrogated him.
4. The [REDACTED] explanation of the pseudonyms [REDACTED] and [REDACTED] does not make sense. He stated the pseudonyms were used for operational security purposes to protect the identity of the capturing personnel and the personnel who captured the detainee would not have been the same personnel who interrogated him. In the statements of [REDACTED] and [REDACTED] they both stated, "It was reported to me that Detainee was detained because he was at the home of...". This clearly demonstrates that [REDACTED] and [REDACTED] were not capturing unit personnel. Further, the memorandum attached as Exhibit 10 to the ROI states "The Temporary Screening Facility administrative staff has used the following pseudonyms during that time period: [REDACTED] It is clear that [REDACTED] and [REDACTED] were TSF personnel.

Exhibit 9 (AIR) contains a paragraph that states interrogation reports were reviewed that had variations of the detainee's name; however, the date of birth on the reports did not match the detainee's date of birth. The AIR does not indicate whether or not the dates of birth were close to the detainee's date of birth. We have found that the same detainee may have numerous dates of birth listed in his records due to a variety of reasons, including admin errors or even because the detainee simply does not know his exact date of birth. Also of note in this case is the fact that the detainee's father was detained during the same time period and the detainee and his father have very similar names. The questioned interrogation reports should have been reviewed for content and compared with subsequent reports that we do have from when the detainee was at Abu Ghraib. The detainee was questioned concerning a very specific issue and the circumstances of his capture were similarly unique. **b(7)(C)-4**

6. The case file contained a copy of [REDACTED] statement; however, it was not attached to the ROI as part of Exhibit 2, which include the detainee records as well as a copy of [REDACTED] statement.

7. Exhibit 5 contained several aliases that were not listed in the VICTIM BLOCK of the ROI, i.e. [REDACTED] and [REDACTED] (apparent misspelling of detainee's actual name).

8. Exhibit 4 reflects that the detainee had another Internment Serial Number [REDACTED] apparently from a previous capture. Should have been listed in the VICTIM BLOCK.

RECOMMENDATION: Reopen this investigation and address the aforementioned issues.

This investigation was initiated upon receipt of RFI 0332-04-CID001, from HQUSACIDC, which indicated a review of [REDACTED] interrogation reports revealed he was allegedly abused while detained by us Coalition Forces.

A review of this case file and investigative reports revealed this detainee was captured and detained by Task Force 6-26. Task Force 6-26 is stationed out of Fort Bragg, NC. A Request for Assistance was sent to the CID asst with this Task Force. An Information Report was provided to this office which stated fake names were used by the 6-26 members. The only names identified by this investigation were determined to be fake names utilized by the capturing soldiers; however, the abuse allegedly occurred during the interrogation of the detainee. The 6-26 CID agent related that the capturing soldiers would not know who the interrogators were. 6-26 also had a major computer malfunction which resulted in them losing 70 percent of their files; therefore, they can't find the cases we need to review.

This investigation meets the necessary requirements and does not need to be reopened. Hell, even if we reopened it we wouldn't get anymore information then we already have.
