INVESTIGATIVE SUMMARY:

On 29 Jul 04, this office received Request for Investigation (RFI) 0370-04-CID001 from the United States Army Criminal Investigation Command, 6010 6th Street, Fort Belvoir, VA 22060, (USACIDC) which requested this office initiate an investigation regarding the death of Mr. HASSON, who died while in United States custody at Camp Bucca, IZ.

Investigation determined Mr. HASSON died while in U.S. custody in Camp Bucca, IZ. Coordination was effected with Mortuary Affairs, Camp Victory, IZ; British Forces, Camp Victory, IZ; BCCF, Abu Ghraib, IZ; Crime Records Center (CRC), Fort Belvoir, VA; Detainee Operations, Camp Victory, IZ; Detainee Processing Center, Camp Bucca, IZ; 160th Military Police Battalion, Camp Bucca, IZ and a review of the Iraqi patient roster that was maintained by the 28th Combat Support Hospital (CSH), Fort Bragg, NC (the medical facility that was operational during the time frame in question) was conducted. All efforts disclosed there as virtually no documentation in reference to Mr. HASSON's manner, cause, or circumstances of death. The only existing record reporting Mr. HASSON's death was a PMO Detainee Not in

Camp Roster. The camp roster only referred to Mr. HASSON as being "dead" with no explanation.

Additionally, based on the PMO Detainee Not in Camp Roster and the Detainee Personnel Report, both reflected the victim was captured on 2003/06/04 and processed on 2003/04/09. Assuming the date is written year/month/day, this would indicate the victim was captured on 4 Jun 03 and processed 3 months prior to his capture. If the date is written year/day/month, this would indicate the victim was captured on 6 Apr 03 but not processed until 4 Sep 03, 5 months later. Due to the inadequate record keeping, this office could only estimate that Mr. HASSON possibly died between Apr - Sep 03.



- 1. On 27 Jul 04, this office received information from the Detainee Assessment Task Force (DATF), in which it was determined Mr Hadi Abdul Hussain Hasson Al-Zubaidy (NFI), died while in detention at Camp Bucca, IZ.
- 2. A review of unclassified military intelligence files revealed a spreadsheet titled "PMO Detainee Not In Camp Roster" which documented eight detainee deaths, four of which were previously documented under a CID Report of Investigation (ROI). Mr Alzubaidy's death was one of the four deaths, which was not reported to CID field elements for investigation.
- 3. Request an investigation be initiated into the above information.
- 3. Request acknowledgment of this RFI no later than 3 Aug 04. Further, request the sequence/report of investigation (ROI) number of the investigation no later than 10 Aug 04. A response to this RFI, to include sequence/ROI number and the status of the investigation, will be forwarded to this headquarters, ATTN: CIOPCOP, no later than the above suspense date. Litter 166-1 About 1100, 13 Oct 04, SAC reviewed the patient roster for the 28th CSH of all Iraqi personnel treated at their facility during the time they (28th CSH) was operational in Iraq. Subsequent to a review of the roster, it was determine that Mr. HASSON was never treated/or brought to 28TH CSH.

AGENT'S NOTE: The information pertaining to the patient roster was received from MAJ -423.66-3 PASBA, Fort Sam Houston, TX. MAJ was assigned to the 28th CSH during his time in Iraq. Area. The 28th CSH was operational at Dogwood Forward Logistics Base from 10 April 2003 through 21 August 2003, at which time the hospital transferred operation to Ibn Sina Hospital in Baghdad. The 28th CSH transferred operations to the 31st CSH on 1 February 2004. Additionally, the 28th CSH established a facility at Camp Speicher, Tikrit on or about 6 June 2003 through 4 February 2004, at which time operations was transferred to the 67th CSH. To date, this office has made numerous attempts to locate documentation which would provide further details as to the circumstances surrounding Mr. HASSON's death. All efforts have met with no avail. No more investigative activity is anticipated at this time. Should additional information be brought to light at a later time, this office will reopen this investigation.


