المسائل التنظيمية والإجرائية

انتخاب أعضاء اللجنة الاستشارية مجلس حقوق الإنسان** *

مذكرة من الأمين العام

١ - وفقاً لقرار مجلس حقوق الإنسان ١/٥، سينتخب المجلس أعضاء لجنته الاستشارية المؤلفة من ١٨ خبيراً يعلمون بصفتهم الشخصية وتعيينهم الدول الأعضاء في الأمم المتحدة بناءً على مشاورات تجريها مع المؤسسات الوطنية لحقوق الإنسان ومنظمات المجتمع المدني. ويجرى هذا الانتخاب بالاقتراع السري من قائمة المرشحين الذين قدمت ترشيحاتهم وفقاً للشروط المتفق عليها.

٢ - ويكون التوزيع الجغرافي للأعضاء على النحو التالي: (أ) خمسة من الدول الأفريقية؛ (ب) خمسة من الدول الآسيوية؛ (ج) عضوان من دول أوروبا الشرقية؛ (د) ثلاثة من أمريكا اللاتинية والبحر الكاريبي؛ (ه) ثلاثة من دول أوروبا الغربية ودول أخرى.

٣ - وقد انتخب المجلس، في دورته السابعة المعقودة في الفترة من ٣ إلى ٢٨ آذار/مارس ٢٠٠٨، أعضاء اللجنة الاستشارية الثمانية عشر، حيث انتخب أربعة أعضاء منهم لمدة سنة واحدة، وسبعة أعضاء لمدة سنتين، وسبعة أعضاء لمدة ثلاثة سنوات.

٤ - وستنتهي في عام ٢٠٠٩ مدة عضوية الأربعة الذين انتُخبو لمدة سنة واحدة. ومن بين هذه المناصب الأربع الشاغرة، هناك منصب لعضو من كل مجموعة من الجمادات الإقليمية، باستثناء مجموعة دول أوروبا الشرقية.

-٥ و عملاً بالفقرة ٧١ من قرار المجلس ١/٥، تُقفل قائمة المرشحين قبل شهرين من تاريخ الانتخاب، وتُتيح الأمانة للدول الأعضاء وللجمهور قائمة المرشحين والمعلومات ذات الصلة وذلك قبل شهر على الأقل من تاريخ الانتخاب. ووفقاً لبرنامج العمل السنوي للمجلس، سينتخب المجلس الأعضاء الأربع في دورته العاشرة.

-٦ وفي ٤ تشرين الثاني /نوفمبر ٢٠٠٨، وجّهت أمانة المجلس رسالة شغوفية إلى المنسقين الإقليميين المعينين من أجل تشجيع اقتراح المرشحين، حيث أفادت بأن الموع德 النهائي لتقديم الترشيحات هو ١٤ كانون الثاني /يناير ٢٠٠٩.

-٧ وقد اعتمد المجلس، في دورته السادسة، المقرر ١٠٢/٦ المتعلق بمتابعة قراره ١/٥ حيث قدّم وصفاً للشروط التقنية والموضوعية لتقديم الترشيحات. وتشمل هذه الشروط:

(أ) الكفاءة والخبرة المشهود بهما في ميدان حقوق الإنسان؛

(ب) التحليلي بخلقٍ سامي؛

(ج) الاستقلال والتراة.

-٨ وينبغي للدول، عند اختيار مرشحيها، أن تطبق المبادئ التوجيهية التالية المتعلقة بالشروط التقنية والموضوعية لتقديم ترشيحاتها:

(أ) الكفاءة والخبرة:

١‘ دراسات أكاديمية في ميدان حقوق الإنسان أو ما يتصل به من مجالات و/أو الخبرة بالأدوار القيادية في ميدان حقوق الإنسان ومارسة هذه الأدوار على المستوى الوطني أو الإقليمي أو الدولي؛

٢‘ خبرة طويلة (لا تقل عن خمس سنوات) وإسهامات شخصية في ميدان حقوق الإنسان؛

٣‘ الدرية بمنظمة الأمم المتحدة وبالولايات والسياسات المؤسسية المتصلة بالعمل في مجال حقوق الإنسان، وكذلك الدرية بالصكوك والمعايير والتخصصات الدولية في ميدان حقوق الإنسان، ويفضّل الإمام بمختلف النظم القانونية والمحضارات؛

٤‘ الكفاءة اللغوية في واحدة على الأقل من لغات الأمم المتحدة الرسمية؛

٥‘ توافر الوقت الكافي لأداء عمل اللجنة الاستشارية على نحو فعال، سواء بحضور دورتها أو بالاضطلاع بالأنشطة الموكلة إليها بين الدورات؛

ب‘ التحليلي بخلقٍ سامي؛

(ج) الاستقلال والتراهنة: يُستبعد الأفراد الذين يشغلون مناصب تُتخذ فيها قرارات في الحكومة أو أي منظمة أخرى أو كيان آخر، الأمر الذي قد ينشأ معه تعارض مصالح مع المسؤوليات التي تشملها الولاية. ويعمل أعضاء اللجنة الاستشارية المنتخبون بصفتهم الشخصية؛

(د) اعتبارات أخرى: يُحترم مبدأ عدم الجمع بين عدة مهام في آن واحد في ميدان حقوق الإنسان.

-٩- وعلى المجلس أن يولي، عند انتخاب أعضاء اللجنة الاستشارية، الاعتبار الواجب للتوزن بين الجنسين والتمثيل المناسب لمختلف الحضارات والنظم القانونية.

-١٠- وبحلول الموعد النهائي لتقديم الترشيحات، وهو ١٤ كانون الثاني/يناير ٢٠٠٩، كانت الأمانة قد تلقت ترشيحات خمسة مرشحين لانتخابات عضوية اللجنة الاستشارية في عام ٢٠٠٩. وقد وردت هذه الترشيحات من حكومات سويسرا والصين وكوبا ومدغشقر والمغرب.

-١١- وترتدد أدناه الترشيحات المقدّمة؛ أما بيانات السيرة الذاتية للمرشحين فترتدى في المرفق الأول. كما تتوفر هذه المعلومات على الشبكة الخارجية لمجلس حقوق الإنسان.
