

We have the honour to draw your kind attention to the recent establishment in Geneva of the Group of Friends United against Human Trafficking.

This Group of Friends together with groups alike in New York and Vienna is aimed at strengthening global counter-trafficking activities under the auspices of the United Nations.

Geneva Group of Friends (GGF) is an informal, voluntary and *open-ended* association of like-minded Member States created to assist to the relevant international organizations and their bodies located in Geneva to effectively implement within their respective mandates the United Nations Global Plan of Action to Combat Trafficking in Persons (A/RES/64/293) and, in a more general sense, to reinforce and consolidate their counter-trafficking activities.

From this perspective we believe that the Human Rights Council has a large potential to effectively address human trafficking through result-oriented human rights based approach. In this context our Group stands ready to constructively cooperate with the Council's relevant thematic special procedures, Member States as well as NGOs that are not indifferent to the alarming worldwide spread of modern slavery.

GGF also seeks close cooperation with other international stakeholders, including the International Organization for Migration, the Office of United Nations High Commissioner for Human Rights, the Office of the United Nations High Commissioner for Refugees, the International Labour Organization, the World Health organization.

To facilitate the work of the Group of Friends the Belarusian Mission is currently exercising functions of the GGF coordinator.

We would be grateful if you could kindly circulate the present letter as an official document of the seventeenth session of the Human Rights Council.
