مذكرة شفوية مؤرخة ١٦ شباط/فبراير ٢٠٠٧ موجَّهة إلى مفوضية الأمم المتحدة السامية لحقوق الإنسان من البعثة الدائمة لكوبا لدى مكتب الأمم المتحدة في جنيف

تُهدي البعثة الدائمة لكوبا لدى مكتب الأمم المتحدة في جنيف والمنظمات الدولية التي تتخذ سويسرا مقراً لها أطيب تحياها إلى مفوضية الأمم المتحدة السامية لحقوق الإنسان وإلى أمانة مجلس حقوق الإنسان، وتتشرف بأن تُرفق طياً نص الوثيقة المعنونة كوبا وحقوق الإنسان بالصيغ الإسبانية والإنكليزية والفرنسية\*.

وترجو البعثة الدائمة لكوبا التفضّل بالإيعاز بنشر النص المذكور بوصفه وثيقةً رسميةً من وثائق الدورة الرابعة لمحلس حقوق الإنسان. وستكون البعثة ممتنة فيما لو أمكن كذلك توزيع الوثيقة على جميع الإجراءات الخاصة التابعة للمجلس، وإتاحتها لمن يهمهم الأمر للاطلاع عليها في موقع الإنترنت الخاص بالدورة الرابعة للمجلس.

### THE REDOUBLING OF THE GEORGE W. BUSH ADMINISTRATION'S HOSTILE POLICIES AND AGGRESSION TOWARDS THE CUBAN PEOPLE: A SERIOUS THREAT TO THE CUBAN PEOPLE'S HUMAN RIGHTS

- **Chapter 1:** The US government's hostility and aggression towards Cuba have reached dimensions unprecedented in the relationship between two states that are not at war.
- **Chapter 2:** A new imperialist programme for subjugating the Cuban nation and recolonising the country.
- **Chapter 3:** The support and/or impunity extended by successive US administrations to perpetrators of terrorist acts against Cuba.
- **Chapter 4:** The human rights of 5 young Cuban anti-terrorist activists wrongly imprisoned in the United States, and those of their families, are grossly violated for spurious political motivations.
- **Chapter 5:** The United States steps up the recruitment, financing and use of mercenaries in its attempt to undermine the right to self-determination of the Cuban people.

- **Chapter 3:** In spite of the unfair anti-Cuban manoeuvre imposed on the CHR, Cuba continues to honour its commitment to cooperate with all non-discriminatory mechanisms in the human rights field.
