#### Special Application Procedure – Deadline Fri., Nov. 22, 2013, 4:00 p.m. CST

A separate process exists or applicants interested in serving fellowships with the International Criminal Tribunal for Rwanda or the International Criminal Tribunal for the former Yugoslavia. Because the ICTR and ICTY require formal institutional nomination, all application materials for their internship programs must be submitted to the Human Rights Center by November 22 at 4:00 p.m. Applicants are NOT to apply directly to the ICTR or ICTY.

PLEASE NOTE: The dates for service with the **International Criminal Tribunal for Rwanda** and the **International Criminal Tribunal for the former Yugoslavia** are somewhat flexible, meaning that a summer internship is possible. The ICTR has a preference for applicants who can serve at least three months, but will accept applications for service ranging in duration from two to six months. The ICTY accepts applications for service ranging in duration from three to six months.

Applicants must submit not only the Tribunal's application materials, but also the application materials for the Human Rights Fellowship Program (except for the letter of commitment from the host organization, and the precise description of your proposed fellowship work, since it will be impossible at this point to know to what work you might be assigned by the Tribunal). These materials must be submitted to the Human Rights Center by November 22, 2013 at 4 p.m. CST.

After November 22, if there are applicants with sufficient qualifications for these highly competitive internships, the Human Rights Fellowship Program will select and present for Dean Wippman's approval one nominee for each Tribunal. The nominees will be assisted by the Human Rights Center in finalizing their applications and submitting them to the Tribunal.

#### **The Application Process**

Applications are accepted from individuals residing in or connected to the states of Minnesota, North Dakota, South Dakota, and Wisconsin. Applicants are encouraged to arrange placements with local, national, or international human rights organizations. Applicants must secure a written commitment from the proposed host organization indicating that the organization will accept the applicant *if* funding can be arranged.

Applicants are encouraged to contact organizations that have previously sponsored interns and fellows from the Human Rights Center or to review reports from past fellows. The Human Rights Center will award approximately 25 grants. Grants will ordinarily range from \$1,000 to \$5,000, averaging about \$3,500, and are intended to cover transportation, food, and lodging during the approximately ten-week fellowship experience.

People from all educational and professional backgrounds are encouraged to apply. However, funding is more limited for people who are not current law or graduate students at the University of Minnesota.

Over the past 22 years, the Human Rights Center has sponsored over 500 interns and fellows to work with human rights organizations in more than 90 countries.

#### Resume (1 page max.)

The resume should summarize your experience in the area of the proposed fellowship, including previous internships or fellowships, travel, education, employment, extracurricular activities, honors, etc. You may also wish to include a brief cover letter highlighting how these experiences will relate to your proposed fellowship.

#### Essay (2-3 pages)

The Essay should detail the following:

- Fellowship placement
- Proposed host organization
- Significance of the experience for your academic or professional training
- Relationship of the fellowship to your future goals
- How the host organization will benefit from a fellowship
- Description of the key aspects of a current human rights issue in the country/location of your proposed fellowship and how the sponsoring organization addresses it
- Description of how you will use your new human rights experiences in your community upon your return home
